Respecting "65% NAVAP"**

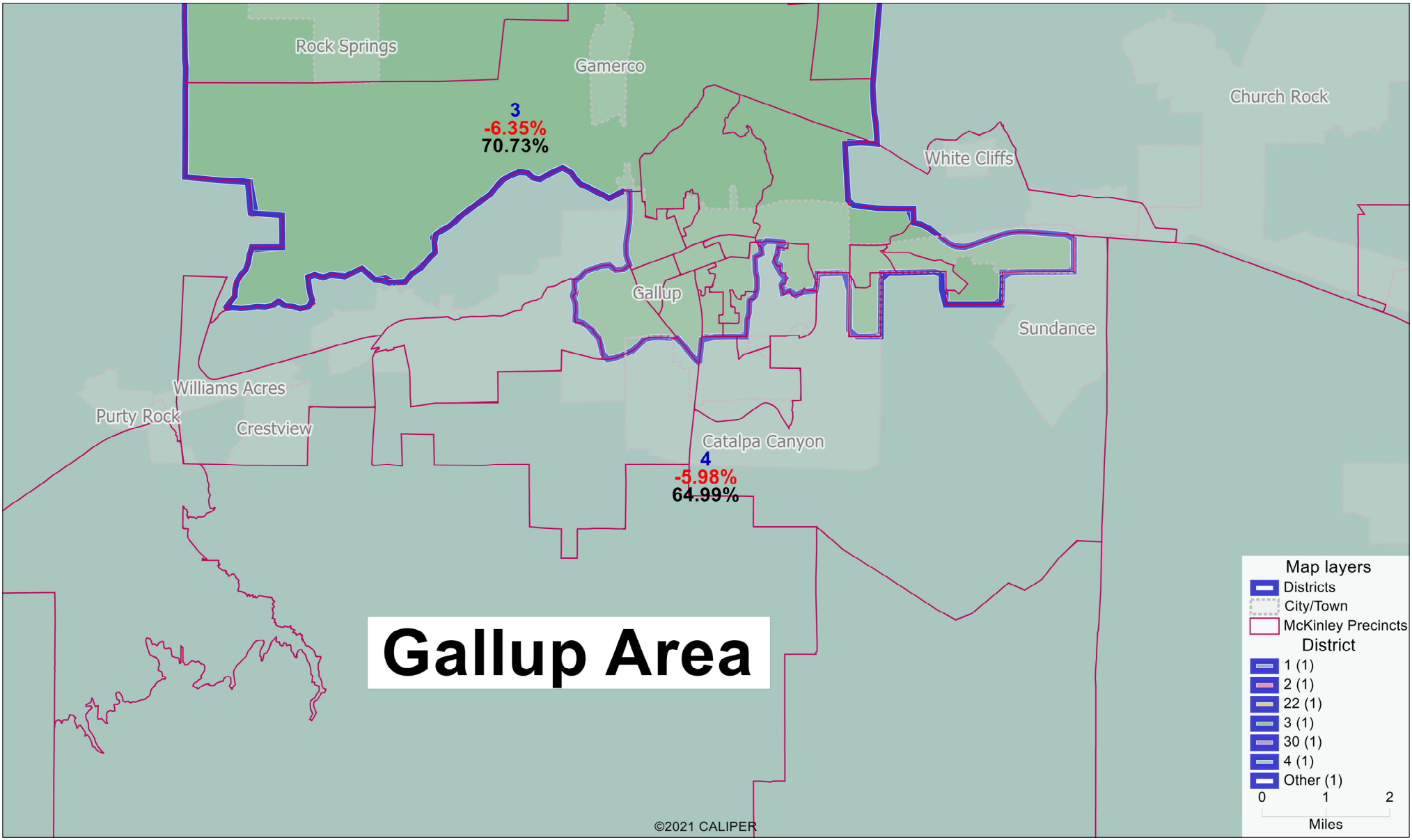
