

**RESOLUTION OF THE
NAVAJO NATION HUMAN RIGHTS COMMISSION**

Selecting the Vice-Chairperson of the Navajo Nation Human Rights Commission

WHEREAS:

1. Pursuant to 2 N.N.C. §§ 920 and 921, the Navajo Nation Human Rights Commission (herein referred to as “Commission”) is established in the Legislative Branch as an entity of the Navajo Nation government and organized to operate as a clearinghouse entity to administratively address discriminatory actions against citizens of the Navajo Nation; and to interface with the local, state, federal governments, and with national and international human rights organizations in accordance with the Commission’s plan of operation (Navajo Nation Council Resolution CJN-15-08) and applicable laws and regulations of the Navajo Nation; and
2. Pursuant to the Commission’s Plan of Operation, Section IV (B) OFFICERS (1), “the Commission shall select from its membership a chairperson and vice chairperson and other officers as may be necessary for the Commission to carry out its authorities and responsibilities. Such selection shall take place when deemed necessary by a majority of the Commissioners, but no later than the end of the first quarter of each calendar year; and
3. By Resolutions NABIS-52-24, NABIS-53-24 and NABIS-54-24, the Naabik’iyat’i’ Committee of the 25th Navajo Nation Council confirmed the appointment by Navajo Nation Speaker, Hon. Crystalyne Curley, of the individuals to become members of the Commission:
 - a. Dr. Henry Fowler, EdD., Education Representative
 - b. Dr. Wendy Greyeyes, Ph.D., Member-at-large
 - c. Roscoe Herrera, Law Enforcement Representative; and
4. On October 15, 2024, the Commission conducted a meeting at which time the Commission selected Commissioner Dr. Henry Fowler, EdD., as its vice chairperson.

NOW THEREFORE BE IT RESOLVED THAT:

The Navajo Nation Human Rights Commission hereby selects Commissioner Dr. Henry Fowler, EdD., as Vice-Chairperson of the Commission and shall serve a term consistent with the Commission’s plan of operation and Naabik’iyat’i’ Committee resolution confirming the appointment as a member of the Navajo Nation Human Rights Commission.
